WHY NBLSA?

For 56 years. The National Black Law Students Association has worked diligently to develop culturally responsible Black and minority law students who excel academically, succeed professionally, and positively impact the community. Our members are activists, thought leaders, and strategic thinkers. Our alumni are general counsels, judges, non-profit executives, business operatives, and change agents. We understand the importance of support within the legal field so we encourage and connect our members and alumni with opportunities to network, seek new professional avenues, and develop life-long friendships.

OUR HISTORY

In 1968, Algernon Johnson ("A.J.") Cooper founded the Black American Law Students Association on the campus of New York University Law School in order to promote the interests of Black and minority law students entering the legal profession. The organization, now known as the National Black Law Students Association ("NBLSA"), was established as a non-profit organization on December 19, 1969. Today, NBLSA is a nationally recognized 501(c)(3) organization and the largest student-run association in the country. NBLSA's structure flows from the national to the regional and local levels. The National Black Law Students Association now consists of 6 regions: Southwestern Region, Mid-Atlantic Region, Northeastern Region, Midwestern Region, Southern Region, and Western Region.

NBLSA PRINCIPLES

NBLSA's programming, events, and initiatives center around four principles that we believe are critical to the development of Black and minority attorneys. NBLSA members work to exemplify, defend, and promote these goals and ensure through oversight that our work is aligned with our mission.

CULTURAL RESPONSIBILITY

NBLSA operates with a profound awareness and deep understanding of the rich history, enduring struggle, and unwavering determination of the Black experience.

ACADEMIC EXCELLENCE

NBLSA endeavors to empower every Black and minority law student, equipping them with resources, hosting impactful programs, and instilling the confidence needed to not only excel but also to conquer the academic challenges of law school.

PROFESSIONAL SUCCESS

NBLSA is dedicated to fostering connections, nurturing skill development, and facilitating opportunities for our members, enabling them to pursue their dream careers.

COMMUNITY IMPACT

NBLSA is committed to nurturing a sense of community engagement by addressing contemporary issues and consistently dedicating our time and talent to serve and uplift the community.

NATIONAL

Guided by the National Chair, steered by the National Executive Board of Directors. and overseen by the National General the Assembly, operates National Board as the compass for policy and programmatic orientation the across entire organization, while also furnishing chapters with resources for the advancement of their programs.

REGIONAL

Under the guidance of a Regional Chair, orchestrated by the Regional Board, and supervised by a Regional Assembly, the six NBLSA Regions dedicate themselves to furnishing vital networking opportunities and programming to distinct geographical areas.

LOCAL

The chapter at the law school level is the heart of NBLSA and where NBLSA's work is most tangibly recognized. Led by a president, and an executive board and overseen by the local membership, the chapter works on behalf of students locally.

PRELAW PROGRAMS

Our Pre-Law division provides proactive pipeline support for college students, offering law school admissions information, LSAT prep, academic retreats, and empowerment resources. With over 60 pre-law chapters and a dedicated Membership Outreach team, we establish new chapters annually. The Annual Pre-Law Symposium at our National Convention facilitates valuable engagement between undergraduate students and law school representatives.

Pre-Law Symposium

The Pre-law Symposium is designed for all pre-law students affiliated with a recognized NBLSA Chapter, as well as those considering law school and interested in gaining insights into what it takes to succeed in law school and the legal profession. We extend an invitation to pre-law students to seize the opportunity to network with fellow aspiring law students, current law students, and lawyers who were once in your position. During the event, you will also receive valuable advice on excelling on the LSAT, navigating the admissions process, selecting your preferred law school, and forging a path to becoming a prominent legal professional. The Pre-Law Symposium will feature expert panels, networking sessions with admissions officers, LSAT prep scholarship giveaways, and an exciting inaugural law school scholarship award.

Thurgood Marshall Moot Court Competition National + Regional Level

Since its inception in 1975, the National Thurgood Marshall Moot Court Competition (TMMCC) has been a cornerstone of NBLSA programming, offering high-caliber competition to showcase oral advocacy and brief writing talents among law students nationwide. Each year, law students compete at our six regional competitions. The top three teams from each region advance to the national competition, which is held during the NBLSA National Convention in March.

Constance Baker Motley Mock Trial Competition National + Regional Level

The National Constance Baker Motley Mock Trial Competition (CBMMTC) provides law students with a platform to improve their oral advocacy skills, legal research, and writing ability and enhance their knowledge of substantive and procedural law. Participants have the opportunity to compete against teams within their respective NBLSA regions. The winning teams from each of NBLSA's six regions are invited to compete at the national competition held during the NBLSA National Convention.

Nelson Mandela International Negotiations Competition National Level

The Nelson Mandela International Negotiations Competition (INC) provides NBLSA members with realistic exposure to alternative dispute resolution. The competition is designed to promote NBLSA's international relations and foster positive relationships between NBLSA members and other law students around the world. The competition is held during the National Convention and requires participants to demonstrate oral advocacy and bargaining skills in a competitive environment.

Baker McKenzie Tax Program

The Baker McKenzie & NBLSA Tax Career Mentor Program was established with the aim of enlightening NBLSA members about the opportunities in tax law careers. This 10-month program pairs students with associates from Baker McKenzie to serve as mentors.

NBA x Mentorship program

The NBLSA x NBA mentorship program is a joint collaboration that will offer a catered mentor-mentee to NBLSA members. Mentors are members of the National Bar Association who are dedicated to developing long-term relationships, advice, networking opportunities, support, and guidance to NBLSA's pre-law and law students. Each mentee will be partnered with a mentor that best resonates with their goals and aspirations within the legal field.

Senate Program

NBLSA has joined forces with the United States Senate to offer exceptional referral opportunities for positions within diverse congressional offices. After you've submitted your application to an office, kindly reach out to us via email, and we will promptly inform them of your NBLSA membership status. This program offers invaluable hands-on experience for members who harbor a passion for policy-making and wish to immerse themselves in the legislative process.

National and Regional Job Fairs

National and Regional Job Fairs offer students exceptional yearround opportunities to connect with a diverse array of employers who actively champion diversity. These events pave the way for interviews with prestigious law firms, corporate giants, and government agencies, making them pivotal in connecting students with potential employers. For organizations, these fairs serve as a crucial avenue to identify and recruit diverse talent from law schools nationwide.

Diversifying the Bench

NBLSA is actively working on multiple initiatives to enhance bench diversification. This year, we have collaborated with Federal Judges to launch our inaugural HBCU Roadshow, scheduled for the Spring semester. In partnership with local bar associations, Federal and state judges will visit our six HBCU law schools to encourage students to apply for clerkships and provide guidance on the application process. Furthermore, NBLSA will distribute the first Black Judicial Directory to all of our members this year.



Charles Hamilton Houston Symposium

The Charles Hamilton Houston Advocacy Symposium honors the legacy of Charles Hamilton Houston who was the first General Counsel of the NAACP who crafted a legal strategy that helped bring about the end of Jim Crow. Join us for a discussion about the importance of Black law students and Black lawyers as advocates. This year we look to honor the legacy of Charles Hamilton Houston at UC Berkeley School of Law while discussing the importance of Affirmative Action, its historical importance to California, and the current status of our Nation following the Supreme Court's recent decision.

Innocence Project Program

NBLSA and The Innocence Project are working together to empower Black law students nationwide, offering mentorship, support, and networking opportunities in criminal justice and civil rights law, along with diverse internship placements in their regional offices.

NBLSA goes to CBC's ALC: Chapter Leadership Retreat

This year, NBLSA is thrilled to reintroduce our annual Chapter Leadership Retreat, taking place in the vibrant heart of Washington, D.C. Spanning four days, this retreat offers a unique platform for chapter leaders to come together, fully engage in the NBLSA ethos, and cultivate a strong sense of camaraderie. All of this unfolds in the nation's capital, coinciding with the prestigious Congressional Black Caucus Foundation's Annual Legislative Conference. As part of the experience, NBLSA organizes mixers and panels featuring congressional leaders, facilitating enlightening discussions on issues that have a profound impact on the Black community.

Pauli Murray Symposium

The Pauli Murray Symposium is an inaugural program designed to establish a prominent platform for profound discussions and dialogue delving into the intricate intersections of identities within the Black legal realm. It specifically highlights the experiences of LGBTQIA+ individuals while paying tribute to and celebrating Pauli Murray's enduring influence on the legal landscape.

SERVICE PROGRAMS

MLK Day of Service

Annually, in homage to the enduring legacy of Dr. Martin Luther King Jr., NBLSA orchestrates a Spring Day of Service. This initiative serves as a profound homage to Dr. King's lasting influence by encouraging chapters to engage wholeheartedly in service projects of their choosing within their local communities. These efforts align with NBLSA's core principles and contribute to the promotion of its values and objectives.

C.A.R.E.S. Program

In 2007, NBLSA introduced the C.A.R.E.S. (Contributing through Advocacy, Resources, Education, and Service) program with the aim of offering NBLSA members opportunities to delve into international legal matters while participating in volunteer work abroad. This year marks the relaunch of the program, which involves sending NBLSA students from various law schools across the nation to engage in international volunteer work, including our first-ever trip to Ghana. To date, NBLSA has collectively contributed over 2,000 hours in volunteer service dedicated to addressing international issues.



Chapter of the Year Competition

The Chapter of the Year Competition presents an annual platform for BLSA chapters and pre-law chapters to highlight their year-long programming and accomplishments, offering the prospect of receiving monetary awards. These coveted Chapter of the Year distinctions are granted at both the National and Regional levels, contingent upon adherence to the comprehensive Chapter of the Year Application packet and associated rubric, which serves as the criteria for eligibility.

This year, we are proudly bestowing our prestigious scholarships with names that honor our top three distinguished alumni donors.

Letitia James HBCU Law School Scholarship

The Letitia James HBCU Law School Scholarship is named after the first woman and Black person to be elected to serve as the Attorney General of New York; this scholarship was created to support HBCU law students who are committed to social justice through public service.

Changemaker Scholarships:

The Charles James Ogletree Scholarship is named after NBLSA's 9th National Chair & CEO, a distinguished American legal scholar, and the visionary founder of Harvard Law School's Charles Hamilton Houston Institute for Race and Justice. This scholarship will recognize an NBLSA member who exemplifies Ogletrees's dedication to social action and sustainable advocacy.

Ketanji Brown Jackson Impact Scholarship:

This prestigious award, bearing the name of the trailblazing first Black woman to serve as a United States Supreme Court Justice, seeks to honor an outstanding NBLSA member who exemplifies the same dedication and humility that characterized Justice Jackson's illustrious career.



WESTERN REGI<mark>ON</mark>

The Western Region has been working hard to "Rebuild the Connection" with our local chapters and the legal community at large. For 56 years, NBLSA has remained dedicated to its mission -to increase the number of culturally responsible Black and minority attorneys who academically, excel succeed professionally, and positively impact the community. As a region we are committed to upholding this mission for our African American Students in the Western Region. Our beautiful region is spread across 9 states (Alaska, California, Hawaii, Idaho, Nevada, Oregon, Utah, Washington, and Guam. Our region represents over 30 schools and over 350 members.





We met our local chapters and got feedback on programs they would like to see. So this year, we have focused on connecting with our members by way of hosting our Career Opportunities Panel Series. We held three panels this semester. First, we held a Black Judges Panel with The Honorable Jamal N. Whitehead, a United States District Judge for the Western District of Washington, The Honorable Richard Bouleware, a United States District Judge for the Western District of Nevada, and Justice Teri L. Jackson a Presiding Judge of the California Court of Appeal, First Appellate District Division 5. Next, we held our Public Interest and Public Service Panel and and a **Sports** Entertainment Law Panel with four attorneys.



MIDATLANTIC REGION

Prelaw Students

For our pre-law students we have made a point to attend various law fairs to connect with incoming students, as well as hosting various events where they can speak with current law students to know what to expect. Our Pre-Law Director has also created a guide to assist OLs as they prepare to enter law school with tips on how to succeed. We have worked closely with regional partners to attract more students to the region for law school and set them up for the best opportunities.



The Mighty Mid-Atlantic Region (MABLSA) has focused our 2023-2024 term on the regrowth of the region. Our focus has been split between our three communities: (1) current law students, (2) pre-law students, and (3) alumni. We have created a number of initiatives to connect with each of these groups to increase engagement and serve the region.

Alumni

For our alumni, we are constantly working to create pathways to reconnect with the region and current students. One initiative we are taking on here is a mentorship program that will connect alumni members with current students. We also tap into our alumni pool to speak on our Black+ panels, where they can share their experiences in the workforce.

Current Students

For current students, our priority group, we have started a number of programs to connect and share information. Our largest is the Black+ Speaker Series where Black attorneys in various fields have honest discussions with students about the benefits and challenges they have encountered while being Black in their specific legal field. We have also made a point to incorporate mental health sessions, to give students an opportunity to decompress from the stress of law school. Other programs include social outings, career fairs, and other networking opportunities to engage with our students professionally.



SOUTHWESTERN REGION

The focus of the Southwestern Region of the National Black Law Students Association (SWBLSA) has been to encourage and maintain relationships with all 20 chapters across SWBLSA to ensure that we are well-connected and supporting students. STRENGTHEN ALUMNI RELATIONSHIPS

SWBLSA thrives off of the participation of our Alumni. Whether it be participating in a panel at a regional event, donating, or helping us curate events for the term, we have been focused on better looping in Black attorneys across the region to promote the growth and maintenance of SWBLSA.

NORTHEASTERN REGION

NEBLSA proudly acknowledges the Northeast region as the foundational pillar of our organization, where we have achieved remarkable milestones over the past seven months. With a focus on creating meaningful experiences, we successfully executed over 50 diverse programs and events, including five Sub-Region Academic Retreats. Notably, 4 of these retreats were hosted at prestigious law firms, with 2, namely New York Metro and Combined Northern New England, graciously sponsored and hosted at Kirkland and Ellis LLP. Our commitment to providing law students with exposure beyond the classroom led us to collaborate with renowned firms, allowing them to step into the professional spaces they aspire to be.



As we continue to evolve, NEBLSA remains dedicated to delivering impactful programs and fostering collaborative partnerships to empower the legal community. Stay tuned for more exciting developments from Notable and Noteworthy Northeast.

ACCOMPLISHMENTS

One of our significant accomplishments includes hosting one of the largest job fairs in NEBLSA's history. The event attracted 93 employers, resulting in 4,051 bids, 153 scheduled student interviews, and a total of 620 interviews conducted on August 5th, 2023. Participating firms ranged from Cadwalader, Wickersham, & Taft LLP to the ACLU-NJ, offering students diverse opportunities. To enhance student readiness, we conducted a Demystifying OCI session in collaboration with Phillips Lytle, drawing over 70 attendees from beyond our region.



SOUTHERN REGION

The Southern Region of the National Black Law Students Association (NBLSA) initiated the current year with the overarching theme, "Safeguarding Our Past, Spotlighting Our Present, and Securing Our Future." This guiding vision is underscored by a series of ambitious goals and initiatives aimed at reinforcing the region's financial foundation, amplifying community and member engagement, and fostering professional development for pre-law and law student members.
